MetroLALSA Over the Years

On October 29, 2010, MetroLALSA was created by twelve Latina/o students from nine law schools who met to discuss the possibility of having a conference in the NY/NJ region. At the meeting, the students did not only discuss the conference idea but also their concerns regarding the status of Latinos at their respective schools, among other topics. They shared one major concern: the student body and the faculty at each of their schools lacked a significant presence of Latinos and, more generally, that there was a strong deficiency of diversity in their law school communities. However, the students recognized that given the high concentration of law schools in the NY/NJ area, they had an invaluable opportunity to join forces and come together to make a greater impact on their schools and communities.



Ultimately, a meeting which was designed to discuss the organization of a conference developed into something far greater. It fostered the birth of an organization of like-minded students determined to empower their communities and support each other, an organization which would later be called MetroLALSA. On April 2, 2011, MetroLALSA hosted its inaugural Pa'lante Conference: Amplifying the Latino Voice in the Law, with nearly two hundred students and professionals gathered at New York Law School for a full-day of panel discussions and networking. No longer merely a conceptual coalition, MetroLALSA became the premier association for Latina/o law students in the New York City region.

Since 2010, seven schools have hosted the Pa'lante Conference, each with a different theme, but always with a clear objective: to bring the Latino legal community together, increase diversity in the legal profession, and develop Latino/a leaders.

Today, MetroLALSA has been recognized as a 501(c)(3) not-for-profit organization, continues to be wholly-operated by law students, and remains a center of support for all its members. MetroLALSA serves as the umbrella organization for the Latino Law Students' Associations from the 13 law schools in the New York-New Jersey metropolitan area. Since our inception, we have participated in voter registration drives, Dream Act rallies and immigration reform demonstrations, and we have organized Street Law: Know Your Rights legal presentations in collaboration with local organizations such as LatinoJustice PRLDEF. We have instituted mentorship programs for current and prospective law students, created a scholarship fund for current law students, and continue to contribute to other academic and social justice initiatives.

WELCOME REMARKS

Mary Lu Bilek



Mary Lu Bilek is the fifth dean of CUNY School of Law and has a deeprooted history with the law school. Dean Bilek first joined CUNY Law in
1985 as a faculty member and then served as academic dean to three of
CUNY Law's deans. She was interim dean during the 2005-06 academic
year. During this time, she played a key leadership role in the law
school's ABA and AALS accreditations. Dean Bilek's commitment to
CUNY Law's values led to her leadership on initiatives promoting more
student-centered instruction, developing and implementing CUNY Law's
innovative curriculum for practice, and spearheading significant
programs—including Pipeline to Justice—and CUNY Law's bar support
program.

Dean Bilek earned her bachelor's degree summa cum laude from St. Mary's College, Notre Dame, Indiana and her J.D. cum laude from Harvard Law School. She practiced law for five years with the firm Paul, Weiss, Rifkind, Wharton and Garrison before joining CUNY Law. Dean

Bilek serves as an ABA Site Visit Team member. She served on the ABA Special Committee on the Professional Education Continuum, and chaired the Section on Legal Education Diversity Committee. She presents regularly on issues related to the future of legal education, diversity in legal education, the bar examination, access to justice, legal incubators, and law pipeline programs. She was appointed by the Massachusetts Supreme Judicial Court to serve on the statewide Access to Justice Commission and to the Board of Directors of the Massachusetts Legal Assistance Corporation.

Blosmeli Leon-Depass is a rising third-year law student at CUNY School of Law. She obtained a Bachelor of Arts in Anthropology and a Master in Public Health degree from the University of Florida. Damaris Hernández



Damaris Hernández is a partner in Cravath's Litigation Department, where her practice focuses on complex civil litigation related to securities, ERISA and antitrust, as well as shareholder demands, internal corporate investigations and government investigations related to the Foreign Corrupt Practices Act. She has represented a range of clients, including American Express, the Republic of Argentina, Credit Suisse, IBM, Merck, Morgan Stanley, Novartis, Vivendi and YPF.

Ms. Hernández also devotes substantial time to pro bono work, representing sick children and their families in partnership with the Children's Hospital at Montefiore and Morgan Stanley Children's Hospital, and acting as lead counsel in a lawsuit in Alabama federal court challenging Jefferson County, Alabama's compliance with a consent decree after findings of discrimination in the hiring of firefighters and police.

She serves as a Fellow of the Leadership Council on Legal Diversity and as a mentor for students in New York University School of Law's AnBryce Scholar program. In 2017, she was elected to serve as a member of The American Law Institute and the Litigation Advisory Board for Practical Law. Ms. Hernández also serves as a District Leader in New York County for the New York State Bar Association and as a board member of the Neighborhood Defender Service of Harlem.

Among other accolades in recent years, Ms. Hernández was named to *Crain's New York Business* 2017 "40 Under 40" list, and has been recognized by publications and organizations including *Benchmark Litigation*, the Council of Urban Professionals, Latino Justice, the *New York Law Journal* and the Puerto Rican Bar Association.

Born in Brooklyn, New York, Ms. Hernández received her A.B. degree magna cum laude in Literature from Harvard College in 2003, and a J.D. from New York University School of Law in 2007, where she was an associate editor of the Review of Law and Social Change and an AnBryce Scholar.

1A: EMERGENCY ADVANCE PLANNING FOR PARENTS AT RISK OF DEPORTATION

DESCRIPTION

The presidential executive orders dated January 25, 2017 on immigration enforcement, effectively put over 11 million people living in the U.S., at risk of detention and deportation. As a result, parents, caregivers, and others are left exposed to catastrophic legal consequences if they are suddenly separated from their children or lose control of their assets. The panel will focus on advance planning issues and documents required for undocumented parents and/or caregivers, including the temporary care of children, designation of a guardian, and New York power of attorneys. The panelists will also discuss the challenges that may arise from working with families, choosing guardians, and/or getting "third parties" to accept documents.

MODERATOR



Kristine M. Garcia is a rising third-year dual degree law student at CUNY School of Law, pursuing her Masters of Public Administration in Inspection and Oversight alongside a J.D. degree. She obtained a double Bachelors degree in Legal Studies and Forensic Psychology with a minor in Political Science from John Jay College of Criminal Justice. Before law school, she had over 10 years of paralegal experience in personal injury, medical malpractice and landlord tenant. She has interned with several organizations focusing on crisis intervention including The Legal Aid Society, NYC Health and Hospitals Corporation, and NYC Department of Probation Juvenile Division. Kristine is most interested in elder law and has worked as a court evaluator on Article 81

matters for the last 7 years. Last summer, she interned at the NY Legal Assistance Group providing legal assistance in elder law matters. This summer she will be a law clerk for a Supreme Court Judge with a focus on elder law and administration. At CUNY Law, Kristine serves as President of PALS (Parents Attending Law School) and is a member of the Latin American Law Student Association. Upon graduation, Kristine wants to continue her work in elder law, and help shape new laws and protections for the elder community.

1B: THE VARIED USES OF ALTERNATIVE DISPUTE RESOLUTION IN THE LEGAL PROFESSION

DESCRIPTION

The panel will discuss the diverse ways that Alternative Dispute Resolution (ADR) is used in different areas of the law. Panelists will discuss the use of mediation to resolve civil disputes, family disputes, criminal justice and restorative justice issues, the use of civil and commercial arbitration, and the use of arbitration in labor disputes. Panelists will also discuss decisions pending before the Supreme Court that could have an impact on the use of arbitration.

Julia M. Ponce is a third-year law student at Hofstra Law School. Julia is a Part-137 arbitrator with experience arbitrating attorney-client fee disputes in Nassau County and is also a trained mediator in Facilitative and Transformative Mediation

techniques. Julia is a zealous advocate, specializing in Criminal Defense, Immigration Law, and Labor Law.

Karen P. Fernbach commenced her career with the National Labor Relations Board upon graduation from St. John's Law School in 1977. In 2012, she was appointed Regional Director of the Manhattan Region. In 2017, she retired after almost 40 years of federal public service. She is currently a Visiting Assistant Professor at Hofstra Law School, where she teaches labor and employment law. Ms. Fernbach received arbitration training from the American Arbitration Association (AAA) and was selected as a fellow of their Higginbotham Program, whose mission is to promote diversity in the training and selection of arbitrators. She is an active member of the ADR and Labor and Employment Law Sections of the NYS

Coleta Walker is the Associate Director of the Red Hook Peacemaking Program at the Red Hook Community Justice Center, where she assists with implementation of the Program and oversees its day-to-day operations. She was previously an art therapist for five years at Rikers Island Correctional Facility and provided art therapy to at-risk youth at the Brunswick Psychiatric Hospital, and to women and children victims of abuse. Peter Miller has been a mediator since 1986 primarily in the family and workplace arenas, and has extensive experience in community mediation cases. He has worked for the U.S. Postal Service's REDRESS Program and other government agencies with workplace mediation programs, including the EEOC and the NYS's Division of Human Rights. He often serves as a trainer and has written extensively about mediation practice and theory. He is currently a Fellow of the Institute for the Study of Conflict Transformation, a policy board dedicated to the furtherance of transformative practices in mediation and is the Director of the Mediation Externship Clinic at Hofstra Law.

1C: SEXUAL HARASSMENT IN THE WORKPLACE: LEGAL AND POLICY GUIDANCE ON CURRENT ISSUES

DESCRIPTION

In 1980, the Equal Employment Opportunity Commission ("EEOC") issued guidelines declaring sexual harassment a Title VII violation of the 1964 Civil Rights Act. Subsequently, in *Meritor Savings Bank v. Vinson*, the Supreme Court affirmed the basic premises of the EEOC's Guidelines as well as the Commission's definition of sexual harassment. *Vinson* established standards for analyzing whether conduct was unlawful and when an employer would be liable. Our panelists will provide guidance on the issues arising in sexual harassment cases in light of the developing law after *Vinson*.

LatinoJustice is recognized nationally for its ground-breaking law reform litigation that has profoundly improved the way Latinos are treated in our society. Perez has been the lead lawyer in a number of ground-breaking immigrants' rights cases which have inter alia: 1) upheld housing protections for non-citizen tenants in NYC; 2) barred attempts to require private landlords in New Jersey to verify the immigration status of prospective tenants; 3) limited local police enforcement of civil immigration warrants; and 4) most recently, securing a precedential court decision finding that a dacamented law graduate can fulfill state character & fitness bar admission licensing requirements, and that the State judiciary can approve bar admission of such applicants even absent any pre-condition state legislative

action expressly authorizing such law licenses. He also works very closely with LatinoJustice's Communications & Community Engagement and Education Divisions on the organization's many innovative pipeline pre-law and leadership programs. He has mentored countless high school, college and law students and new lawyers of color over the years.

Perez is a 1985 graduate of St. John's University School of Law. He began his legal career as a prosecutor with the Queens County District Attorney's Office and the NYC Housing Authority's Anti-Narcotics Strike Force. He also worked at the NYC Legal Aid Society for over ten years, starting as a staff attorney in the Juvenile Rights Division representing children & juveniles in Family Court proceedings, and later serving as a supervising attorney in LAS' Civil Division Brooklyn and Harlem Neighborhood Offices overseeing the housing and family law practices. He also spent a year at Hofstra Law School supervising student attorneys in the Housing Rights and Disabilities Law Clinics while teaching lawyering and litigation skills. Prior to joining LatinoJustice, Jose served as an Assistant Attorney General, Deputy Chief, and Acting Chief of the NYS Attorney General's Consumer Frauds & Protection Bureau.



In her current position, her chief responsibilities include: counseling prospective students, developing the Law School's national recruiting strategy each year, handling the bulk of the recruiting for the Law School, and evaluates hundreds of applications for the J.D. program each year. She created and manages the Student Ambassador Program, and oversees the Housing program for all St. John's law students. She collaborates and cultivates relationships with Pre-Law Advisors from undergraduate schools around the country, as well as, students, alumni, and faculty to continue recruiting the next generation of attorneys.

Dorothy's initiatives have greatly enhanced St. John's Law School's recruitment efforts. In her

Pipeline Program: Mock 1L Class

DESCRIPTION

Join Professor Cohen and Professor McLaughlin as they teach a mock law school class for pipeline students based on *Jennings v. Rodriguez*, a 2017 Supreme Court case ruling that immigrants do not have a right to bail in connection with their detention by ICE.

PANELISTS



Professor Randolph M. McLaughlin, a graduate of Columbia College and Harvard Law School, became Of Counsel to Newman Ferrara LLP in September 2011. Professor McLaughlin is a faculty member at Pace University School of Law, where he teaches courses focusing on civil rights, litigation, labor law, voting rights, civil procedure, and New York practice. Before joining Pace's law faculty in 1988, Professor McLaughlin was associated with Meyer, Suozzi, English & Klein, where he specialized in civil litigation and labor law. In 1978, he began his legal career at the Center for Constitutional Rights, a civil-rights/civil-liberties legal organization in NYC. In 1982, he won an award of \$535,000 for five black women who had been attacked by members of the Chattanooga Ku Klux Klan. In 1985, Professor McLaughlin represented two civil-rights leaders in a constitutional-tort action against a former U.S. Senator, a Senate investigator, and a Kentucky prosecutor, in connection with the search and seizure of the plaintiffs' personal papers in violation of the Fourth Amendment. On February 20, 1997, Professor McLaughlin won a landmark victory in a voting-rights case against the Town of Hempstead, N.Y., entitled Goodby v. Town Board of

the Town of Hempstead. In addition to his litigation practice, Professor McLaughlin has represented and advised not-for-profit charities in connection with governance and best-practice issues. In 2001, Professor McLaughlin was appointed special counsel to Hale House Center which provides 24-hour residential care for infants and toddlers who were born to drug addicted mothers unable to care for their children. Professor McLaughlin successfully negotiated a resolution of an investigation by the NYS Attorney General into the charity. After a new Board of Directors was appointed, Professor McLaughlin was retained to serve as general counsel to assist in the restructuring of the organization.



Debra S. Cohen co-chairs Newman Ferrara LLP's Civil Rights Practice Group where she concentrates in litigation involving police misconduct. Ms. Cohen's first civil rights case involved the 1996 death of Charles Campbell – shot in a Westchester parking lot by an off-duty NYC police officer (who was later convicted of second degree murder and sentenced to twenty years to life in prison). In a subsequently filed civil suit, a federal jury awarded the Campbell family a multi-million dollar verdict. Since then, Ms. Cohen has represented a wide variety of clients whose civil rights and constitutional entitlements were violated by police, schools, local planning and building department officials, as well as private employers. In addition to her litigation practice, she has also written op-eds which have been published by the New York Times, the New York Daily News, Gannett's Journal News and other regional and national newspapers. In an article published by the New York Law Journal on February 17, 2017, Ms. Cohen advocated for reform of how the NYPD responds to calls involving people with mental illnesses. In 2017, Ms. Cohen's professional contributions and achievements were acknowledged by the Westchester Martin Luther

King, Jr. Institute for Non-Violence. Ms. Cohen is admitted in the State of New York, as well as the United States District Courts for the Southern and Eastern Districts of New York, and the United States Court of Appeals for the Second Circuit. A graduate of Vassar College and Pace Law, she has been an Adjunct Professor at Pace since 2005 teaching civil rights law.


